Approving the Amended Gu Achi District Dance Request Agreement Form

WHEREAS, the Gu Achi District Council established a quorum at a regularly scheduled meeting in the Community of Santa Rosa on October 26, 2013 to address issues regarding the district; and

WHEREAS, the District Council has approved resolutions to amend the District's Dance Rules pursuant to Resolution #1301-338 which states that *"This resolution shall be revisited for amendments at any time when needed"*; and

WHEREAS, the Gu Achi District's Policy and Procedure Committee (PPC) did receive comments and recommendations regarding the District's dance rules *"Dance Request Agreement Form"* in regards to the *"ADDITIONAL SECURITY"*; and


